Gifts of stock may be made via electronic transfer. Oak City Cares maintains a brokerage account with Fifth Third Securities for the purpose of processing stock transfers to Oak City Cares. **Oak City Cares cannot initiate stock transfers on your behalf. You must contact your broker directly. If Oak City Cares does not receive this form, we may be unable to identify electronically-transferred stock.**

Stock market fluctuations after the date of delivery (as defined above) will not affect the charitable deduction for tax purposes.

Oak City Cares will sell stock as soon as possible (usually by the business day following the receipt of the stock). The net proceeds will be affected by the actual sale price, as well as a broker charge to process the transaction. Accordingly, there will be a variance between the charitable deduction amount and the net proceeds applied from the gift. Oak City Cares cannot be responsible for any variance in these amounts.
